I. INTRODUCTION:

The Regional Centre for Urban & Environmental Studies (RCUES), Lucknow was established at the University of Lucknow in the year 1968 by the Ministry of Housing and Urban Affairs (earlier referred as Ministry of Urban Development), Government of India. It is one of the premier Centres in the country established to play a positive role in the field of urban management. The key activities of the Centre includes Training, Capacity building, Research, Teaching, Consultancy Services and dissemination of information relating to the Urban Sector in the states of Uttar Pradesh, Madhya Pradesh, Bihar, Odisha, Uttarakhand, Jharkhand, Chhattisgarh, UT Chandigarh, Manipur, Sikkim. The centre provides its expertise, advisory services & consultancy services to urban local bodies all over the country.

II. BACKGROUND

Mandated by the Ministry of Housing and Urban Affairs, Government of India to address the concerns of urban managers and enhancing their capacity by ways of research and trainings. For more than fifty years, RCUES Lucknow has been working in various States throughout the country, focusing on building a brighter future for towns and cities.

Because of these five decades of extensive experience, from the highest levels of policy formulation to a range of schemes and projects, RCUES has gained a distinctive and a universally accredited expertise in all things urban. This has placed RCUES Lucknow in the best position to provide answers and achievable solutions to the current challenges faced by our city managers. It works to ensure that the city managers become prepared and farsighted drivers of economic growth and social development.

The key activities of the Centre includes Training, Capacity building, Research, Teaching, Consultancy Services and dissemination of information relating to the Urban Sector specifically in ten States of India viz Uttar Pradesh, Madhya Pradesh, Bihar, Odisha, Uttarakhand, Chandigarh UT, Jharkhand, Chhattisgarh, Sikkim and Manipur, though the Centre provides its expertise, advisory services & consultancy services to urban local bodies all over the country. The Centre provides need based consultancy support to the various state governments.

1. In view of the above RCUES Lucknow has decided to empanel agencies to create a pool of capacity that can provide technical support to implement various

projects/studies/evaluations/trainings in the field of urban sector and to help ULBs to design, structure, and manage various urban development schemes/ programmes effectively in cities and towns.

2. RCUES, Lucknow proposes to empanel Consultancy Firms, Joint Ventures, Consortiums, Agencies, Individual Consultants and NGOs initially for one year extendable and for a total period of upto 3 years. Expression(s) of interest (EOl) are invited from Consultancy Firms, Joint Ventures, Consortiums, Agencies, Individual Consultants and NGOs which have adequate experience in dealing with matters pertaining to Urban Sector.

3. Eligibility/ Qualification Criteria:

The following are the eligibility criteria for submission of EOI:

- i) The Consultancy Firms, Joint Ventures, Consortiums, Agencies, Individual Consultants and NGOs shall be well acquainted with the statutory & regulatory environment in the urban sector and possess relevant experience.
- ii) Shall have adequate administrative and financial capability to undertake the tasks assigned.
- iii) Should have an annual turnover of not less than Rs. 2.00 Crore (Rupees Two Crore only) per year for the past 3 (three) consecutive years and a certificate to this effect should be submitted from the Auditor of the Firm.
- iv) If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria". (vide Policy Circular No. 1(2)(1)/2016-MA dated 10th March, 2016 and Para 16 of Public Procurement Policy for Micro and Small Enterprises Order 2012 and Rule 160(i)(a) of GFR, 2005)
- v) As per the Government of India **Start Up India** action plan, all startup firms/companies registered under the startup India programme by the government of India are exempted from the prior experience and prior turnover under the eligibility and prequalification criteria for the bidders. (Any bidder claiming exemption from the minimum eligibility criteria as a start-up firm/company shall submit a self-declaration on the letterhead of the bidder duly sealed and signed by the authorized signatory along with a self-certificate, copy of certificate of recognition issued by the Department of promotion of industry and internal trade ministry of commerce and industry, government of India.
- vi) The firms registered as MSME are exempted from paying/submitting Earnest Money Deposit (EMD) as per the MSME rules of Government of India.
- vii) Further, any Bidder which has been barred by Government of India/ any State Government/ Government agency, Supreme Court /High Court or any lower court within last three years as on date of EoI submission, would not be eligible to submit an EoI. An undertaking stating the same must be submitted along with the EoI.

4. The Firm shall furnish copies of certificate of registration/agreement/articles of association, as the case may be, as service firm and PAN, and GST Registration.

5. Tenure of Empanelment.

The initial empanelment will be for one year or until further orders whichever is earlier. The same may be extended for one year at a time for a total period not exceeding 3 years.

6. Consultancy Firms, Joint Ventures, Consortiums, Agencies and NGOs are required to give their proposals in writing providing their credentials and requests for empanelment. Details are to be given as per the format enclosed in Annexure A.

The proposals so received from the **Consultancy Firms, Joint Ventures, Consortiums, Agencies, Individual Consultants and NGOs** shall be evaluated on the following criteria.

- Length of Relevant Experience in Providing Urban Sector Services:
 - Assessment based on the number of years the firm has been providing services in the urban sector.
 - Applicants/Firms must submit documentary proof and a list of clients.
- Sound Financial Standing of the Applicants/Firms:
 - Evaluation based on the annual turnover of Firms and agencies during the last three financial years. Relevant certificate from an auditor must be appended.
 - Evaluation based on the ITR of individual consultants.
- Number of Qualified Employees/Experts in the Urban Sector:
 - Number of employees/experts engaged by the firm who have more than 5 years of experience in providing urban area services.
 - Applicants/Firms must furnish CVs of the consultants engaged by the firm.
- Level of Client Satisfaction:
 - Evaluation based on the satisfaction level of previous clients.
 - Applicants/Firms must attach certificates from the client's organizations.
- Experience in Urban Sector Assignments/Projects Related to ULBs or State Parastatals :
 - Assessment based on the firm/individuals' experience with assignments or projects related to Urban Local Bodies (ULBs) or State Parastatals.
 - Relevant project details and proof of experience must be provided.

7. Submission of EOI

Interested and eligible Consultancy Firms, Joint Ventures, Consortiums, Agencies, Individual Consultants and NGOs may submit their Application Form in the prescribed format (Annexure A) with complete information and documents. The Application Form duly filled in, along with all supporting documents/information should be submitted by post in a closed envelope super scribing as "Expression of Interest (EOI) for Empanelment of Consultancy Firms, Joint Ventures, Consortiums, Agencies, Individual Consultants and NGOs working in Urban Areas" at the following address:

8. Tender Fee:

- i. The **Consultancy Firms, Joint Ventures, Consortiums, Agencies, Individual Consultants and NGOs** applying for empanelment would be required to submit Tender fee (nonrefundable) as under:
 - a. In case of, Joint Ventures, Consortiums- Rs 15000/- (INR)
 - b. In case of Consultancy Firms, Agencies and NGOs- Rs. 10,000/-
 - c. In case of Individuals Rs 1000/-
- ii. The Tender Fee should be submitted along with this EOI in the form of Demand Draft from any nationalized bank/scheduled bank of India and drawn in favour of the Regional Centre for Urban & Environmental Studies, Lucknow payable at Lucknow, Uttar Pradesh, India.
- 9. Entities currently debarred/blacklisted by any agency or any authority in India or elsewhere shall be ineligible to apply or be considered for empanelment. Applicant firm/ consultant should give a declaration that the firm has not been blacklisted or debarred by any agency or any authority in India or elsewhere (Annexure B).
- 10. The criteria and weightage indicated are for the purpose of empanelment only. Specific evaluation criteria may be included in the RFP for selection process for individual assignment, if required.
- 11. Debarring Provisions or Removal from Panel

The Consultancy Firms, Joint Ventures, Consortiums, Agencies, Individual Consultants and NGOs working in Urban Areas may (on discretion of RCUES Lucknow) be debarred from empanelment for present and /or in future under any or all of the following conditions:

- \circ If the firm obtains the empanelment on the basis of false information/misstatement.
- It does not take up work in terms of empaneled letter.
- Giving false and/or misleading information to RCUES Lucknow relating to projects or assignments.
- Threatening and/or intimidating and/or abusing any of the employees or officers or representatives of RCUES Lucknow.
- If the firm indulges in any misappropriation of RCUES Lucknow's funds in any form or/and commits an act tantamount to professional misconduct.
- Not acting as per RCUES's specific instructions repeatedly.

Empanelment shall be liable to be cancelled consequent upon occurring of any or all of the above said conditions/events.

RCUES Lucknow reserves all rights to reject one or all the proposals without assigning any reason thereof.
