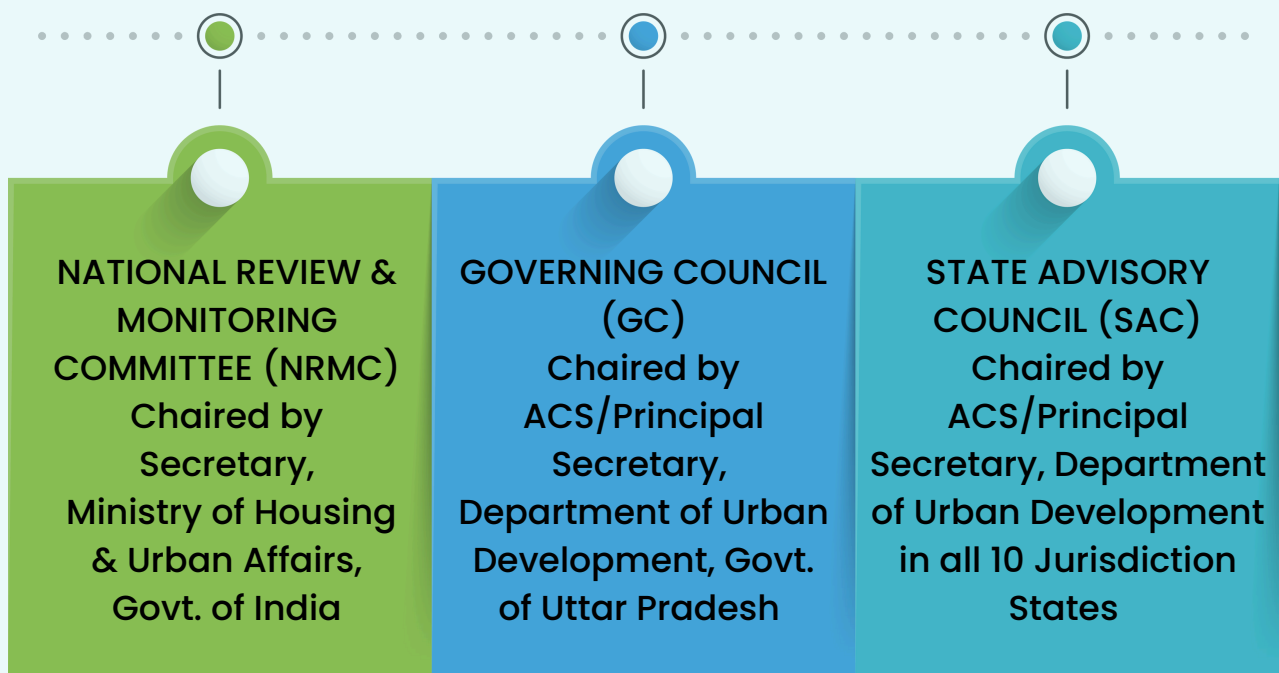
Our Management

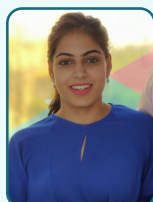

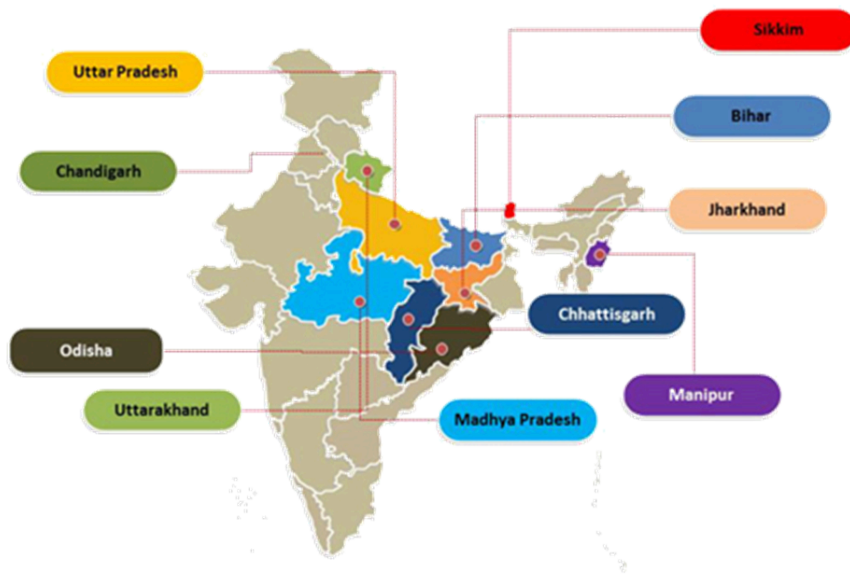

- **Disaster Risk Management in ULBs**

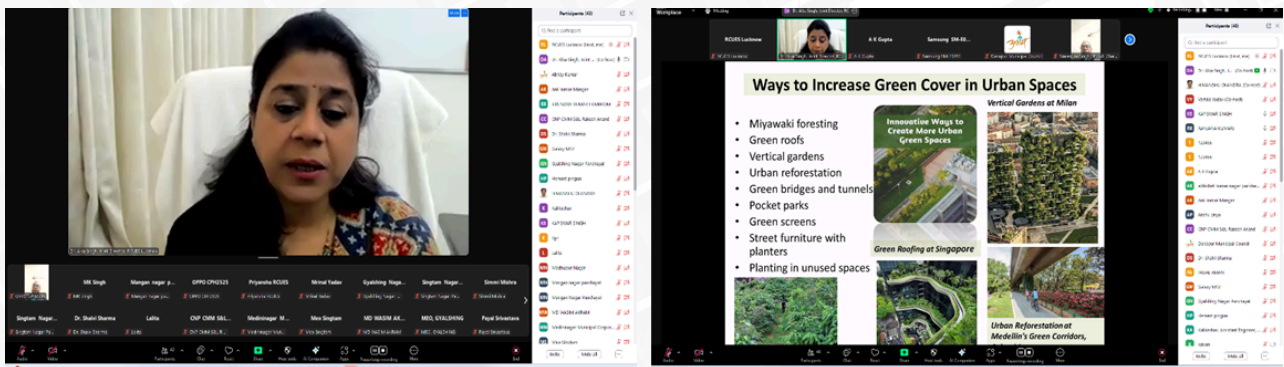

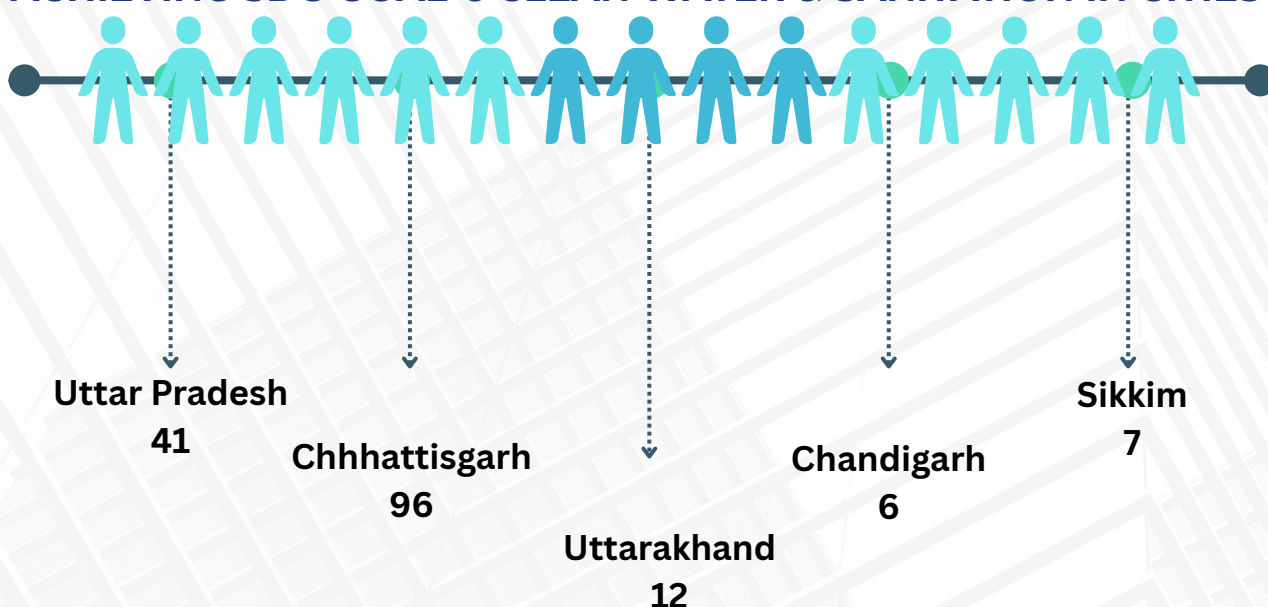

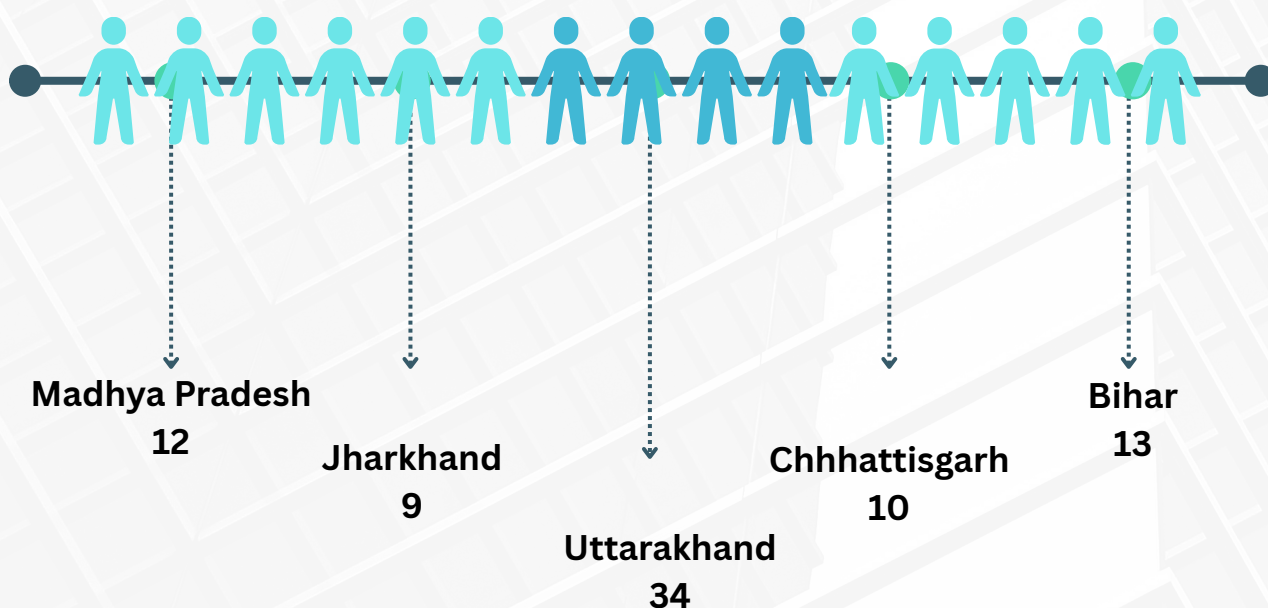

CLIMATE ACTION FOR CITIES: SDG-13

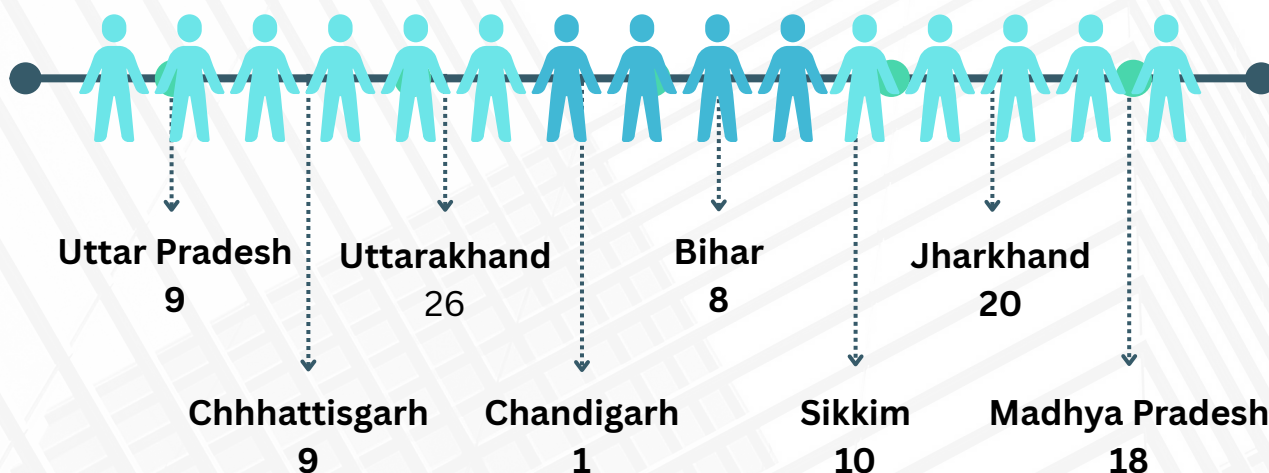

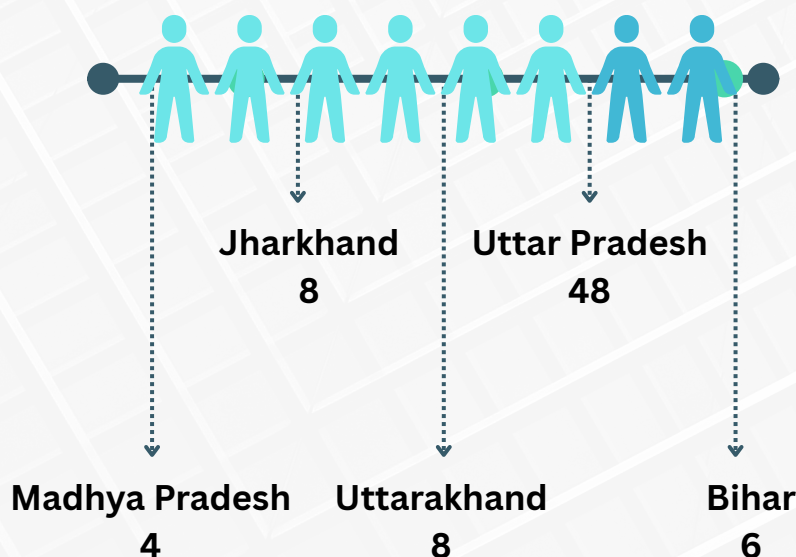

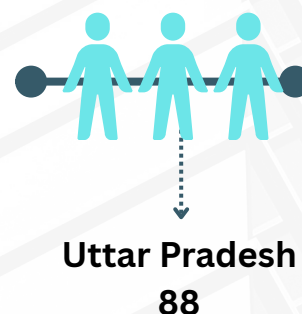
DEVELOPMENT OF GREEN SPACES & PARKS IN ULBS

URBAN TRANSPORT (CORRIDOR & JUNCTION IMPROVEMENT PLAN)

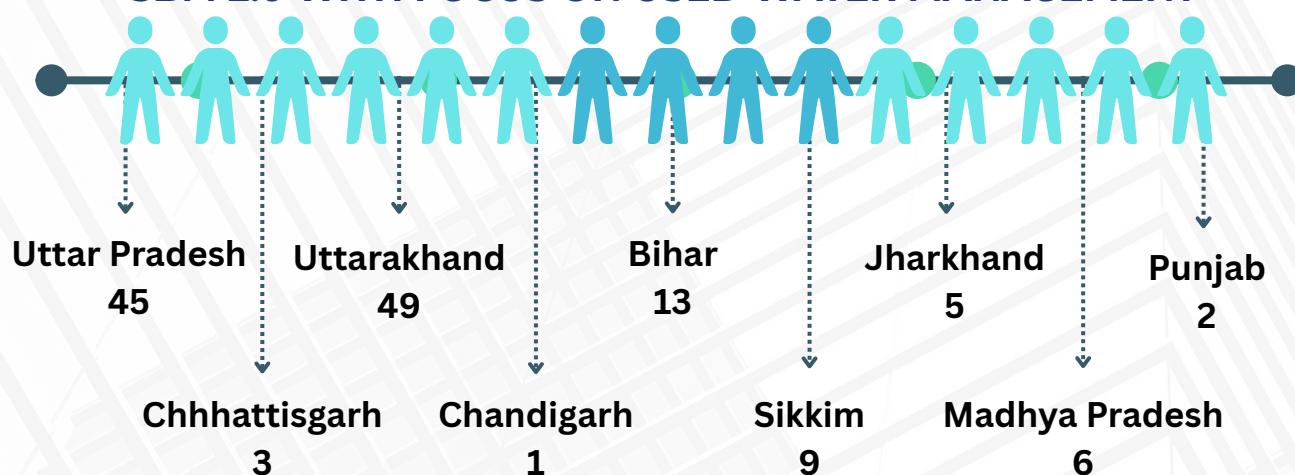

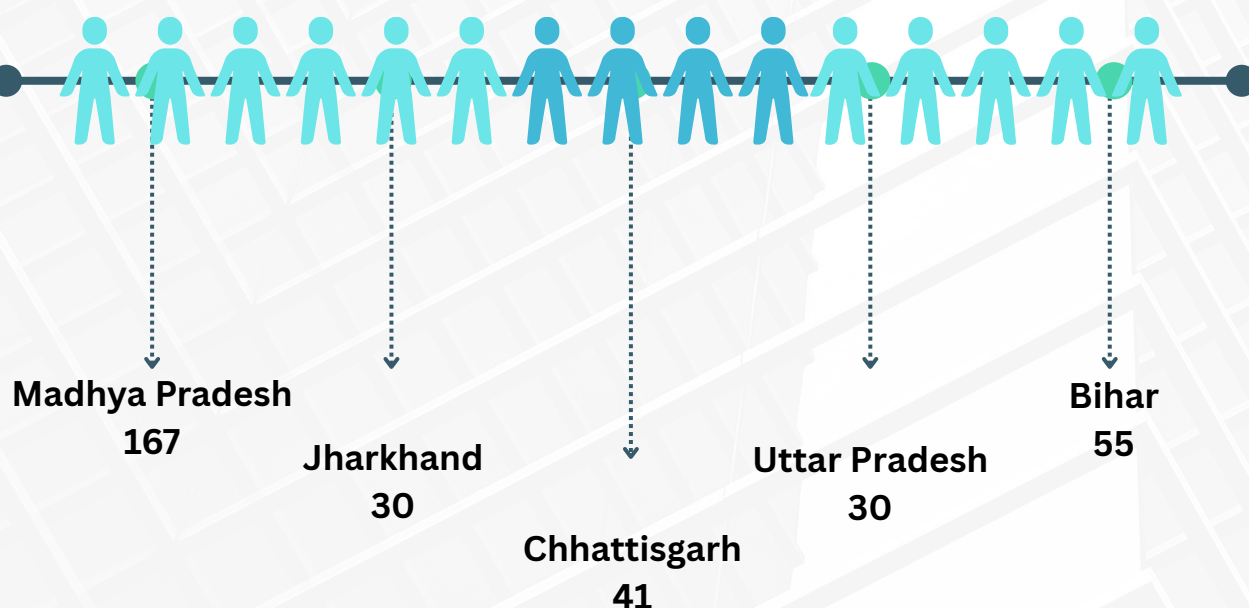

MICRO CREDIT TO STREET VENDORS IN URBAN AREAS

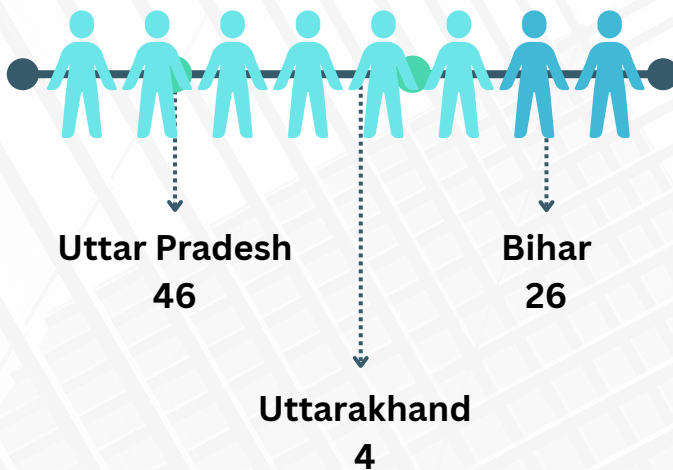

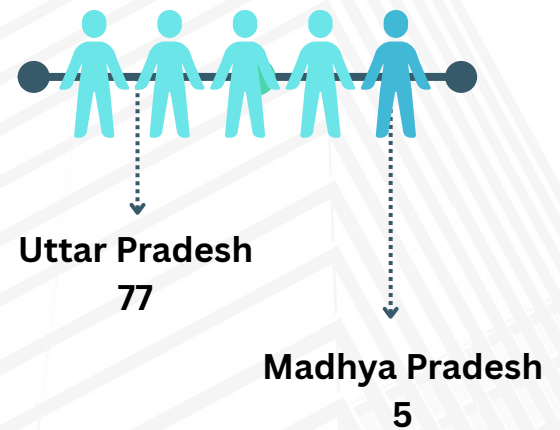

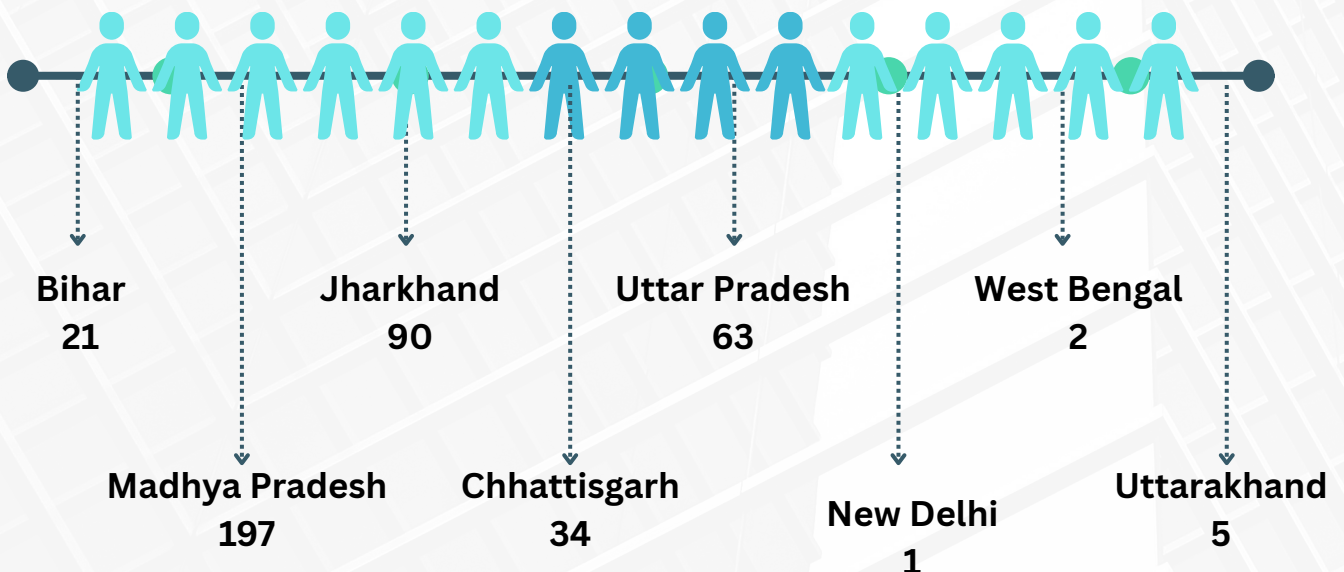
GIS BASED MASTER PLAN, LOCAL AREA PLAN & TOWN PLANNING SCHEME IN URBAN AREAS

INCLUSIVE HOUSING POLICY

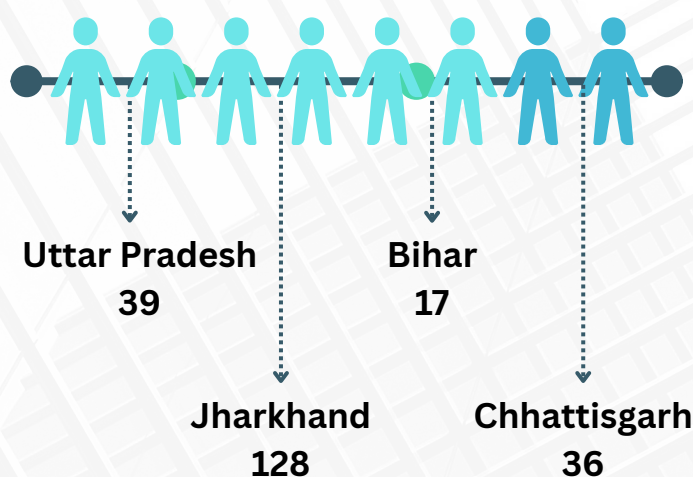

CAPACITY BUILDING INITIATIVES UNDER SBM 2.0

In line with the objectives of Swachh Bharat Mission 2.0 (SBM 2.0), the Regional Centre for Urban and Environmental Studies (RCUES), Lucknow organized a series of three online training programmes exclusively for Elected Representatives of Urban Local Bodies (ULBs) in Uttar Pradesh. These sessions were curated to strengthen leadership at the grassroots level and to promote informed, participatory, and strategic decision-making in urban sanitation.

Targeting Mayors, Chairpersons, Councillors, and Members of Nagar Panchayats, the trainings aimed to empower local leaders to effectively champion and oversee sanitation and waste management reforms in their respective jurisdictions.

Objectives of the Training Programme

- To build a comprehensive understanding of SBM 2.0 provisions and focus areas
- To enhance the capacity of elected representatives in implementing sustainable, inclusive sanitation strategies
- To encourage community participation and behavior change through impactful IEC activities
- To share successful case studies and promote scalable models in solid and used water management

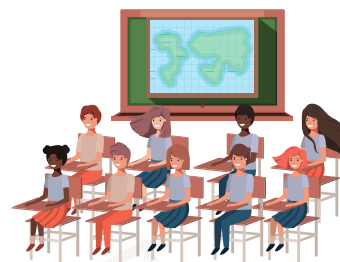

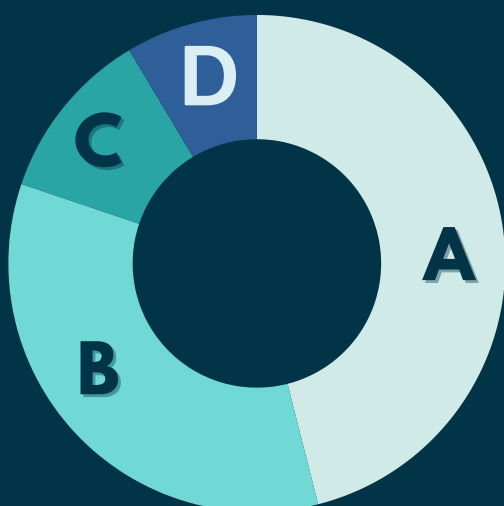

5th June

Theme: Revive Land, End Desertification, and Secure Water



In celebration of World Environment Day on 5th June 2024, the Regional Centre for Urban & Environmental Studies (RCUES), Lucknow organized a one-day workshop centered on the global theme “Revive Land, End Desertification, and Secure Water.” The initiative aimed to promote awareness and proactive measures for sustainable water and land management practices. The event brought together experts, municipal officials, environmentalists, and development practitioners to exchange ideas, share best practices, and chart actionable paths toward ecological conservation.

The workshop was designed with the following objectives:

To raise awareness on the pressing issues of land degradation, desertification, and water scarcity.

To share innovative and sustainable practices in land and water resource management.

To foster collaboration among Urban Local Bodies (ULBs), policymakers, and environmental experts.

To encourage collective action and mobilization of resources for environmental sustainability.

The workshop commenced with an inaugural ceremony where key dignitaries emphasized the significance of World Environment Day and underscored the urgency of addressing environmental challenges. The opening address laid the groundwork for the day’s discussions, reinforcing the commitment to the theme and the goals of the workshop.

Technical Sessions

Holistic Water Resource Management

Experts highlighted the importance of managing the complete water cycle—from sourcing and distribution to treatment, reuse, and safe return to the environment. Emphasis was placed on multi-stakeholder collaboration for integrated planning and implementation.

Water Quality Improvement

Discussions focused on strategies to reduce water pollution through regulatory enforcement, community awareness, and robust monitoring and assessment systems. Participants explored practical approaches to safeguarding freshwater ecosystems.

Wastewater Innovation

Urban Local Bodies (ULBs) were encouraged to become hubs of innovation by adopting advanced sewage management systems, managing urban stormwater runoff, and implementing recycling and reuse of wastewater. Technological advancements and successful case studies were presented to illustrate replicable models.

Best Practices and Case Studies

Interactive presentations showcased successful case studies from across India, highlighting scalable and sustainable initiatives in water and land management. These sessions served as inspiration and practical guidance for ULBs to replicate within their jurisdictions.

The workshop was attended by 42 professionals representing various urban governance and planning roles, including: Joint Municipal Commissioner, Deputy Municipal Commissioner, Assistant Municipal Commissioner, Executive Officers, Assistant Engineers, Junior Engineers, District Programme Managers (SBM), Revenue Inspectors, Sanitary and Food Inspectors, Planning Consultants, Programme Managers, and Senior Assistants.



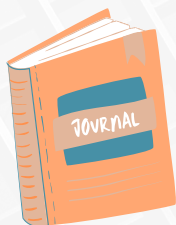
